The Coordinator, Learning Assessment Programs, manages a team of assessment professionals and reports to the Director, Programs Directorate, who is a member of the organization's senior leadership team. The Coordinator, Learning Assessment Programs, works directly with: senior representatives of international and pan-Canadian education committees; international organizations, such as the Organisation for Economic Co-operation and Development (OECD) and the International Association for the Evaluation of Educational Achievement (IEA); federal government departments with an interest in student assessment; and other relevant stakeholders.

Currently, the Learning Assessment Programs Unit coordinates pan-Canadian participation in three international and one pan-Canadian large-scale assessment studies:

- the Programme for International Student Assessment (PISA);
- the Trends in International Mathematics and Science Study (TIMSS);
- the Progress in International Reading Literacy Study (PIRLS); and
- the Pan-Canadian Assessment Program (PCAP).

- Superior command of French and English (both written and spoken)
- Graduate degree (Master's or Ph.D.) with specialization in assessment or educational measurement or any similar educational credentials
- Excellent knowledge of large-scale test development, research methodology, statistical analysis, and reporting (including familiarity with advanced statistical packages such as SPSS)

- Exceptionally detail-oriented, with strong project-management and organizational skills, and the ability to provide project deliverables on time and on budget
- Highly developed collaborative, networking, and negotiating skills to work with a broad spectrum of government officials, international organizations, and other stakeholders
- Ability to exercise discretion and tact in highly confidential and politically sensitive situations
- Highly developed decision-making and problem-solving abilities
- Demonstrated experience managing large-scale projects
- Experience with large-scale assessments, typically gained through senior project experience at ministries of education or related provincial/territorial/national organizations, educational institutions, or private educational-assessment companies
- Leadership skills and content expertise to provide ongoing feedback and coaching to colleagues and project teams
- Knowledge of educational systems and assessments in Canada
- Experience managing human resources, including hiring, onboarding, performance management, coaching, and mentoring
- Experience leading a business unit, including operational planning and performance monitoring
- Experience as a member of an organization's leadership team
- Experience managing an operational budget, including variance analysis
- Experience negotiating contracts
