

## **Surrey Community Counselling Clinic Director**

The Faculty of Education, Simon Fraser University, seeks applications for a full-time continuing Lecturer position / teaching faculty member in the Counselling Psychology program, who will serve as the Director of the SFU Surrey Community Counselling Centre (SCC).

### **Qualifications**

- Doctoral degree in Counselling Psychology or related field
- Minimum 5 years clinical practice with children, youth and families
- Minimum 5 years experience conducting clinical supervision of graduate students
- Experience with telehealth and technology related to supervision
- Experience working with clients of diverse and marginalized backgrounds including Indigenous and newcomer clients, and capacity to practice and supervise from a multicultural social justice perspective
- Able to contribute to Faculty priorities of Equity, Indigeneity and Inquiry
- Registration with BC College of Psychologists, or eligibility to register, or Certified Supervisor with CCPA or BCACC

### **Assets**

- Knowledge and proficiency with technology involving recording and viewing of sessions and technology-related ethical concerns
- Knowledge of Surrey-based social and health services and/or schools
- Experience developing or delivering psychotherapy groups with a strengths and resilience-based approach

### **Responsibilities**

- Teach a minimum of 2 courses/ year or equivalents
- Oversee Counselling Psychology graduate program admissions process
- Oversee all administration and operation of the SCC
- Year-round presence in the SCC, to liaise with the Surrey Anti-Gang Family Empowerment (SAFE) project, requiring up to 3.5 days onsite/week
- Train and supervise the work of the clinic support staff
- Ensure referral database is maintained
- Supervise or conduct screening interviews and book client appointments
- Develop and maintain referral networks in the community
- Provide student orientation to clinic operation and procedures
- Monitor student work in the clinic
- Ensure client records are maintained and stored in accordance with ethical standards and legal requirements

- Coordinate with faculty and program’s academic coordinator regarding any remediation plans for graduate students whose performance is unsatisfactory
- Contribute to the Counselling Psychology program operations and development to promote alignment of program’s clinical and academic training
- Provide psychotherapy (individual and family) to children, youth and families referred to the SCC
- Supervise Master’s level counselling trainees as they conduct psychoeducation and psychotherapy individually or in groups with children, youth and families at the SCC
- Support EDUC 799/800 (Clinic) Instructors (Supervisors)
- Represent SFU SCC as clinical training center and consult with other Canadian Masters training centers for best practices
- Liaise with the Surrey Anti-Gang Family Empowerment (SAFE) program, staff and practicum for SCC policies and scheduling

### **HOW TO APPLY**

1. A signed **application letter** that describes the applicant’s qualifications and teaching experience, and potential contributions to the wider Faculty.
2. A current curriculum vitae.
3. The names and contact information of three referees. Please do not ask referees to send letters of reference in advance.
4. A scholarly publication.

**Deadline** for applications is **March 30, 2024**. Only short-listed candidates will be contacted.

Faculty salaries at SFU are based on the salary scales bargained between the University and the SFU Faculty Association. A reasonable estimate of the salary range for a continuing full-time
